# Education Officer Rick Unis

I am devoting this month's Chalk Talk to a look at the upcoming course schedule between now and spring. I asked for inputs on what boating education courses you would like to have offered but I received very little in the way of feedback, with the exception of the Sea Scouts. I have done my best to assemble a broad array of course offerings that offers something of value to the general public and to all of our squadron members. My course plan includes a host of Squadron Boating Courses offered in various locations to meet the demand for boating safety certification (see our website for details on these courses). In addition, a variety of advanced education courses and electives will be offered to include Piloting (fall), Advanced Piloting (spring), Navigation (fall/winter), Marine Electronics (fall/winter), Cruise Planning (winter), Weather (winter/spring) and Seamanship (fall and a possible course in the spring too). Further, there will be several seminars offered to include Using a Chart; Anchoring; and Knots, Bends & Hitches. That's a pretty full load of courses that will require a commitment from our instructors and from you to sign up for a course that interests you. Here is the current schedule for advanced courses, electives and seminars starting in the fall and winter that are open for registration. Note - the Piloting and Marine Electronics courses started in early September and are ongoing. The Navigation course will start as soon as the new books are published – currently estimated for sometime in October.



# CONGRESS RESTORES 35-YEAR EXEMPTION FOR RECREATIONAL BOATS FROM PROPOSED EPA PERMITTING REQUIREMENTS

#### NO NEW PERMIT FOR BOATS REQUIRED

ALEXANDRIA, VA, July 22, 2008 - In a remarkable display of bipartisan support for recreational boating, both the House and Senate today passed S. 2766, "The Clean Boating Act of 2008" which will permanently restore a long-standing exemption for recreational boats from permitting requirements under the Clean Water Act. The legislation now goes to the White House for the President's signature.

Congressional action was spawned by a U.S. District Court decision in September 2006 under which an estimated 17 million recreational boats would have fallen under Clean Water Act permit requirements effective September 30, 2008. The permit would have dictated maintenance and operation procedures and potentially subjected boaters to citizen lawsuits as well as a penalty system designed for industrial polluters.

BoatU.S. Government Affairs Director Margaret Podlich was quick to shower praise on a boatload of legislators who did much of the heavy lifting including Sens. Bill Nelson (D-FL) and Barbara Boxer (D-CA) and Representatives Jim Oberstar (D-MN), Steve LaTourette (R-OH), Candice Miller (R-MI) and Gene Taylor (D-MS). BoatU.S. has worked for more than a year with the National Marine Manufacturers Association and a broad coalition of stakeholders to resolve the problem before the permitting deadline.

"One of the real keys to success here was our collective ability to activate the grassroots," said Podlich, noting that tens of thousands of letters and e-mails were generated by boaters and anglers over the course of the past 12 months.

The Dangers of Carbon Monoxide

Anyone who has taken a boating safety course is aware of the dangers of carbon monoxide poisoning. Fortunately, today's vessel designs and standards that require carbon monoxide detectors in all sleeping spaces have made carbon monoxide incidents a rarity. Given this, it is easy to become complacent about the risks associated with carbon monoxide.





Do you know that ....

You cannot see, smell, or taste carbon monoxide? Carbon monoxide symptoms are similar to seasickness or alcohol intoxication? Carbon monoxide can affect you whether you're underway, moored, or anchored? Carbon monoxide can make you sick in seconds. In high enough concentrations, even a few breaths can be fatal?

Do you know carbon monoxide poisonings are preventable? Carbon monoxide is a colorless, odorless, and tasteless gas that is produced when a carbon-based fuelsuch as gasoline, propane, charcoal, or oil-burns.

Carbon monoxide enters your bloodstream through the lungs, blocking the oxygen your body needs. Prolonged exposure to low concentrations or very quick exposure to high concentrations can be lethal. Early symptoms of carbon monoxide poisoning include irritated eyes, headache, nausea, weakness, and dizziness. These symptoms are often confused with seasickness or intoxication, so those affected may not receive the medical attention they need. Carbon Monoxide sources on your boat include engines, generators, cooking ranges, space heaters and water heaters. Gasoline engines, including gasoline generators, are the primary source of carbon monoxide on boats. Diesel engines produce only about 15 percent of the carbon monoxide of their gasoline counterparts, so although the risk is still present, it is greatly reduced. The most common source of carbon monoxide is improperly vented engine exhaust. Situations that present this problem are typically inadequately ventilated canvas enclosures (exhaust gas enveloping the boat in still air blocked exhaust outlets , exhaust from adjacent boats back-drafting or "station wagon effect" and, proceeding at slow or idle speeds

A review of safety incidents over the past several years indicates the most prevalent cause of carbon monoxide poisoning is engine generators running overnight at anchor. The second most prevalent cause is faulty maintenance of the boat exhaust system allowing gases into the cabin, followed to a much lesser extent is back drafting situations.


The good news is that carbon monoxide poisoning is very preventable. To begin, every boat, especially gasoline boats, should have a carbon monoxide detector in each sleeping space that is permanently wired to the boat's electrical system. If you have an older boat that was not equipped with carbon monoxide detectors, you need to have them installed. You also need to consider. Anytime the detector alarms should be considered a hazardous condition that needs to be addressed, Know where and how carbon monoxide might accumulate in and around your boat, Never hang on the swim platform when the engine or generator is running, Maintain fresh air circulation throughout the boat at all times. Although carbon monoxide can be present without the smell of exhaust fumes, if you smell exhaust fumes, carbon monoxide is also present. Take immediate action to dissipate these fumes, Make sure all exhaust clamps are in place and secure, and treat symptoms of seasickness as possible carbon monoxide poisoning.

Carbon monoxide poisoning or toxicity is a life-threatening emergency that requires immediate action. Keep in mind that the victim may be in an area of high carbon monoxide concentration, which means you or others could in danger from exposure to carbon monoxide. Correct ventilation problems and/or repair exhaust problems as appropriate. Investigate the source of carbon monoxide and take corrective action, such as evacuating and ventilating the area or shutting off the source of the Carbon monoxide, while at the same time evacuating and ventilating the area.

Carbon monoxide is not something you need to fear, just respect.


