



# Executive Officer's Report:

I feel like I'm preaching to the choir writing this to the Power Squadron, but the frequency of stupid boating accidents is appalling. Driving a power or sailboat safely is not intuitive. It's something that has to be learned and taken seriously. It's not just like driving a car. There aren't any lines painted on the road to tell you where you should be. There isn't a warning to tell you when you're about to run out of road or run aground. At night you don't have headlights to show the way, and other boats may only show up as a single red or green light. And bad weather can play havoc with your cruise. The only similarity with driving a car is if you're intoxicated driving either one, then you and the boats or cars around you are in danger of serious accidents

And yet we hear all the time of accidents caused by stupid boaters. And these aren't stupid people. The Maryland state delegate who collided with another boat and seriously injured a young girl admitted to a 0.2 blood alcohol reading. He wasn't stupid, but he was drunk out speeding in his Go-Fast boat. The Long Island skipper who put 27 people on his 34 foot cruiser and then let his friend drive the boat at night ended up killing three kids who were trapped in the cabin when the boat capsized after hitting a large wake. That was stupid. The list of these kinds of accidents goes on and on. Sean Gallagher in his column last month listed several recent accidents that could have been avoided.

The bottom line is, if you're going to drive a boat, take some lessons, learn the rules of the road, and get a Basic Boating Certificate. Even this won't prevent you from doing something stupid, but at least you'll know what you should be doing. The Power Squadron's whole reason for being is to promote boating safety so people can have fun on the water and not endanger others. So spread the word down at your marina that the Power Squadron offers a wide variety of classes designed to make people better boaters. We have experienced instructors who can pass along tips they have learned and answer questions. Far superior to online courses which seem to be the way things are going.

# Education Officer's Report

#### Chalk Talk – September 2012

Greetings Shipmates! Hope you all have had a fulfilling summer and avoided most of the intense heat. We're entering the second half of the 2012 season and by the time you read this, the course list for the period October 2012 through April 2013 will be posted to the national site (usps.org) and the squadron calendar on the website. Then, it will be up to you to register and attend the classes. If you have a desire for specific courses, please let us know and we'll try to substitute. Remember, we'll need a minimum of 8 students to conduct any of the courses so as we now offer all of our courses to the public (for a slightly increased price), bring all of your family and friends so they'll be as smart as you and be able to take over in the event you become disabled. Even at nonmember prices, the courses, texts and handouts are well worth the price. With fall coming on, you may be interested in taking the engine maintenance course so you'll be ready to winterize and clean up your boat for winter. Fall and Winter seasons are also a perfect time to participate in one of the USPS seminars to brush up on your GPS or VHF radio skills. The seminar instruction finishes in two to three hours with plenty of time left to ask questions.

Speaking of training, the weather course is now available online through the University of West Florida. While this course is no substitute for the classroom edition taught by our own Dr. WX, John Shivik, it would serve as a great opportunity to become acquainted with the dynamics of weather or a great review.

Get Educated — Stay Safe

I want to remind all of you smart phone users that there is a source out there for boater apps for IPhone and Android phones. Access to these apps is available through the Education Department web page (usps.org/eddept) on the left side navigation menu under Miscellany. A form is also available on the page for you to submit other boating-related apps you've found useful.

Ah yes, the benefits of completing USPS advanced courses. Successful completion of advanced courses results in significant insurance discounts for the member. The premise behind the USPS Boat Insurance Program is to reward members for their dedication and passion for on-the-water safety by providing reduced insurance premiums. On top of low base rates, USPS Boat Insurance customers can reduce their premium even further, *up to 23%*, through completion of various USPS advanced courses. And completing boat operator certification can add to these discounts as much as an additional 15%, for a *total discount of 38%*! See the USPS Boat Insurance web page for details.

Lastly, a reminder that we are also entering the 2012 hurricane season. Boat owners from Maine to Texas can be impacted by this severe weather. Each year, on average, two hurricanes come ashore somewhere along the Gulf or Atlantic coasts, destroying homes, sinking boats, and turning people's lives inside out for weeks, or even months at a time. Experts predict that in the next 20 years there will be much more hurricane activity than has been seen in the past 20 years. Experts also fear that after a number of storm-free years, people in some of the vulnerable areas will be less wary of a storm's potential fury. But to residents of Charleston, South Carolina, crippled by Hugo in 1989, and people in Dade County, Florida, ravaged by Andrew in 1993, the hurricane threat won't soon be forgotten. They cleaned it up a tad and band-aided the wounds (mind you they did not bandage) and sent us to the waiting room. Ah what a night/morning. Now 4:24 a.m. we are waiting. A nurse took a look and 4 hours later the doctor stopped by and agreed it was an animal bite and rabies shots were ordered. They say they average about two animal bites a day. A shot in each wound, a tetanus shot in the arm, and two rounds of rabies shots were little compared to the bite of ER, to Dave; another shot on Tuesday, a third on Friday, another in a week, plus a bill, we are told, of near \$7,000. I wonder who ER will chew on next weekend..... Maybe YOU... Close your doors at night when on the dock or ER might come for you. Fun times!!!




# Vessel safety checks

The hot days of summer may be over and some of you may be thinking of cruising this fall. Part of your cruise planning should be getting a Vessel Safety Check (VSC) and displaying the VSC decal on the port side of your vessel. Having a VSC decal distinguishes you, unfortunately still a minority, as having met the basic safety criteria. The items on the check list in fact are state and/or federal requirements:

- 1. Having a valid boat registration on board
- 2. Registration/documentation numbers properly displayed
- 3. Signaling devices, audible & visual, on board (not expired)
- 4. Navigation lights in working order
- 5. Sanitation device properly configured to prevent discharge overboard
- 6. Personal flotation devices & throwable on board
- 7. Engine compartment ventilation & back fire flame arrestors (gasoline engines)
- 8. Fire extinguishers; proper number and size based on vessel type/size
- 9. I did leave several mandatory items off this list (to qualify for a VSC decal): DO YOU KNOW WHAT THEY ARE?



Having a valid VSC sticker is particularly beneficial to those of you planning a trip South/North on the Intracoastal Waterway this Fall. Two of our NVSPS Examiners, Robin Roberts and George Degnon, have been and will be checking vessels planning a trip on the ICW.

So far this year, the NVSPS Vessel Examiners have conducted 134 VSCs. ALL the vessels participating in the Wounded Warrior Cruise – 2012 will need a Vessel Safety Check (most have already done so).

The NVSPS General Meeting Presentation for September will be "Sailing at Night" by our own member Rich Unis, an experienced sailor and active squadron member.
